- No lessons may be scheduled unless they have been prepaid or there is a credit card on file
- All cancelations require 24 hours notice or you will be charged for the lesson
- Because instructors may schedule lessons back to back, all Private lessons will run for thirty (30) minutes from the scheduled start time, all semi-private lessons will run for forty (40) minutes from the scheduled start time
- All swimmers must either check in at the front desk or if non members must let the NAC staff know that they are participating in private lessons
- For lessons that are not prepaid, we will automatically charge your card on file the day of the lesson.

As parent or legal guardian of participant, on behalf of the swimmer(s), I warrant and represent they have no disability, impairment or ailment preventing them from engaging in active or passive exercise. This representation is made by me knowing that the Club will rely upon it in allowing them to participate in this program.
